Longevity will hereby be paid annually, in a separate paycheck to all eligible employees, on the payday for the second pay period in December. Longevity pay will be made in a lump sum, a maximum of \$1,200 (\$100 per month served after two years of service in the calendar year) regardless of the employee's position and is subject to statutory paycheck deductions. Longevity is not considered a part of any employee's base annual pay.

All employees and elected officials are eligible provided they have completed 2 years service.
